

## **TIBURON ESTATES HOA—THE MASTER ASSOCIATION**

Tiburon Estates HOA—known as TEHOA to members, is the Master Association which is responsible from the gatehouse to the end of Castillo Court, including the main road and 10 feet either side of it, the fountains, street lights on the Boulevard, almost 500 Royal Palm trees, 40 coconut palms, and landscaping in the medians and to its road boundaries.

It also controls the gatehouse staff and the bulk hotwire service that is provided to all associations in Tiburon Estates

The 9 communities that comprise Tiburon Estates HOA are :-

Marsala, Marquesa Royale, Bolero, Esperanza (1 and 2), Castillo, Serafina, Escada, Ventanas, and Norman Estates.

The Master Association approves all requests for transponders that are obtained from the CDD, for all communities except Marsala. It is **very important** that you complete the forms on pages 12 (application for transponder) and 14 (online voting and notifications form) and return to tgurtner@kwpmc.com at your earliest convenience.

We also liaise with both the Golf Club and the Ritz Carlton to organize concessions on occasion for the TEHOA.

### MID-RISE NEIGHBORHOOD ASSOCIATION

This is a third association that pertains to <u>Ventanas and Esperanza I & II only</u>. For these associations Mid-rise is responsible for the two pools and spa areas (umbrellas, lounge chairs, outdoor grills, kitchen and dining areas and bathrooms), all of the landscaping of the roads, sidewalks, paver driveways and street lights **within** Ventanas **and** Esperanza I & II communities. The association has its own separate board of directors that manages its own operating and reserve budget and is managed by Newell Property Management.

## PELICAN MARSH COMMUNITY DEVELOPMENT DISTRICT (CDD)

The Pelican Marsh Community Development District was established in 1993 to provide for the financing and operations of one of Southwest Florida's largest master planned communities. With 2,075 acres and over 3,000 homes, this CDD manages the property on Tiburon Drive from the Airport Pulling entrance past the Ritz Carlton hotel to the entrance on Vanderbilt Beach road. This includes landscaping, street maintenance, lighting, and sidewalks. Community Development Districts are a subdivision of State government and are created by the Board of County Commissioners. The District is overseen by a 5-member Board of Directors who are elected public officials.

The cost to operate the CDD is borne by those who benefit from its services. Property owners in the CDD are subject to a non-ad valorem assessment, which appears on their annual property tax bill from the county tax collector and may consist of two parts—an annual assessment for operations and maintenance, which can fluctuate up and down from year to year based on the budget adopted for that fiscal year—and an annual capital assessment to repay bonds sold by the CDD to finance community infrastructure and facilities, which annual assessments are generally fixed for the term of the bonds. Because costs and services vary depending upon the individual CDD, specific fee information is available for each community.

All of Tiburon Estates EXCEPT Marsala fall under the Pelican Marsh CDD.

## Welcome to Tiburon Estates

The Tiburon Estates HOA – also known as the Master Association, is responsible for the approval of all Transponders. These are issued by the Pelican Marsh Community Development District - known as the CDD. This allows Residents who wish to purchase a transponder to pass through the resident lane of the Gate on Tiburon Blvd East, through their own community gate (excluding Marsala) and also access through Pelican Marsh.

## How to obtain a Transponder: New Owners:

- The Property Manager of the sub association should complete the Gate form application and email to tgurtner@kwpmc.com – this will enable us to inform the gatehouse team that you will be arriving on the close date and will be given permission to enter through the guest lane. Please note, these forms are NOT accepted if completed by realtors.
- 2. .When you close on your new property please ensure that a copy of the deed and closing statement have been sent us by your title company: This allows us to get you moved in as a new owner and show up on our systems.
- 3. Once all documents are received we approve and send to the CDD who will update their records.
- 4. You will need to make an appointment with Pelican Marsh CDD by calling 239-592-5181 Ext 1 Transponders Lot location on next page this is where you will go for your appointment time.
- 5. You must take your registration and driver's license.
- 6. Transponders for **RENTAL Vehicles** These will <u>ONLY</u> be issued for the duration of the rental (or lease term if less) and your name <u>MUST</u> appear on the rental paperwork.
- For LEASED vehicles Transponders will ONLY be issued if the leased vehicle is either in your name, or in the case of a Company car – the lease <u>must</u> show you as the named driver – please bring a copy of the lease to avoid delay.
- 8. NO COMMERCIAL VEHICLES at all can be issued with a Transponder
- <u>9.</u> There is a fee for the transponder ranging from \$20 \$50 depending on type of vehicle. <u>Payment will</u>
   <u>ONLY be taken by cash or check.</u>
- 10. After you receive your transponder you need to go to the gatehouse to have it entered in their computer before it will work on main gate or any of the kiosks at Escada, Serafina, Marquesa Royale, Bolero or Norman Estates. The gatehouse staff will do their best to accommodate all requests subject to very busy periods.

## CHECKPOINT Visitor Screening System

Tiburon uses The Checkpoint System which offers Residents several ways to Pre-Clear expected guests and Manage your contact information at the gate. When you move in and register, your Property Manager will send you a link to sign up to check point. There is also a handy APP that can be used from your phone.

Once you have settled in and you are ready to set up your visitor list, please contact your property manager for your association who will send you out specific instructions for your community to help you to download the Apps for the system.

Once you have completed the visitor list set up, you will be able to easily update any vendors or visitors to your unit, pull reports of who has been allowed access and what times, etc. The system will also send you notifications via text or email when guests arrive so you are alerted to their arrival.

Please note this is an automated lockbox which is a mechanical facility at the bank. We do not handle any checks

The Property Manager will send out a friendly eblast reminder 2 weeks before the due date each quarter to help residents to pay in a timely manner.

Any assessments that are unpaid for more than ten (10) days after the date due shall incur late fees.

If the Assessment is not paid within **sixty (60) days** after the due date, the Homeowners' Association may, at any time thereafter, accelerate the entire amount due for the period for which the Assessment was made, and declare the same immediately due and payable. The Homeowners' Association may also record a claim of lien in the Public Records setting fourth the amount of the unpaid Assessment and the rate of interest due thereon. The Homeowners' Association may at any time thereafter bring an action to foreclosure the lien against the Dwelling and/or a suit on the personal obligation against the Owner or Owners, and there shall be added to the amount of such Assessment the cost of such action (including reasonable attorneys' fees and costs through all appellate levels) and, in the event a judgement is obtained, such judgement shall include interest on the Assessment, and late charges as provided above and reasonable attorneys' fees through all appellate levels, together with the costs of the action.



# **Before you Leave Check List**

- Turn off your main water valve.
- Shut off breaker to water heater.
- Shut off breaker to other kitchen appliances....EXCEPT refrigerator (double check to make sure the refrigerator is ON, after you shut the breakers off).
- Shut off your ice maker, and empty all of the ice from the freezer
- Empty refrigerator of all perishables.
- Empty all garbage receptacles. Make sure no open food or drink is left in any room.
- Set thermostat to 76 degrees to cut electric use, but prevent mold.
- Replace the 9 volt batteries in all smoke alarms.
- Unplug all televisions and electronic devises to prevent damage from power surges.
- Forward your mail to your other residence.
- Stop newspaper deliveries.
- Temporarily discontinue telephone, and internet service (most carriers will allow seasonal shut-off).
- Remove any live plants from your unit, unless home watch will be watering them.
